Summer Horse Camp Checklist*

What to pack checklist for your four-legged friend:

- ✓ **Please make sure that your horse has had all necessary vaccinations and health certificates complete upon arrival.**
- ✓ Water bucket/s and grooming tools.
- ✓ A hay bag or net if you would like your horse to be fed off of the ground.
- ✓ Bedding: Depending on location bedding may or may not be provided (Please ask us if you need to provide your own bedding).
- ✓ We can provide hay for your horses for an additional charge; however, we recommend that you provide your own hay.
- ✓ \$50 per week if you provide hay, bedding, daily cleaning of pen.
- ✓ \$75 per week if we provide hay. You are still responsible for bedding and cleaning of pen.
- ✓ \$95 per week if we provide hay, bedding, and daily cleaning of pen.
- ✓ Tack (saddle, saddle pad, bridle, any other equipment needed for riding your horse).
- ✓ Certified Equine Riding Helmet.
- ✓ Any grain, supplements or medications you may be feeding your horse. Don't forget a bucket or tub to place the grain in.
- ✓ Fly spray, fly mask/fly sheet if you normally use one for your horse.
- ✓ Water Proof Blanket (if you blanket your horse during rainy weather).
- ✓ Horses coming from **out of state** will need to have proof/copy of a current negative coggins test and health certificate.
- ✓ Horses coming from **in state** will need to provide proof that the horse is currently vaccinated.
- ✓ Please **label all equipment**. We are not responsible for lost or misplaced equipment. Bringing a plastic tub or two to store majority of equipment is suggested.

Facility Rules:

- ✓ Please clean up after you and your horse (all manure from tack up areas, round pen, and indoor/outdoor arenas, hair droppings, trash, etc.). Wheelbarrows/rake located in shed, as well as garbage cans.
- ✓ A schedule of weekly riding lessons is posted in tack shed so that you may check and plan schedule for available arena riding times.
- ✓ Do not tie your horse solid to round pen/panels, you may loop it in case your horse were to spook it would pull free.
- ✓ Do not tie to round pen at all if it is in use.
- ✓ Please keep all gates closed.
- ✓ Be cautious of electric fences.
- ✓ All minors under age of 18 must wear a helmet when riding.
- ✓ All minors must have a parent or guardian present when working with their horse or riding unless they are in a scheduled riding lesson with Cedar Ridge Equine instructor or scheduled with an adult that is on site.
- ✓ All riders must sign a release of liability before riding.
- ✓ Please label all of your belongings that you keep on site (tack, brushes, blankets, helmets etc.
- ✓ Please keep your space in tack room neat and tidy.
- ✓ Please respect speed limit of 20 mph on Rocky Road.
- ✓ Park in designated parking areas.
- ✓ All dogs must be kept in vehicle or on leash unless permission is given from facility owner.
- ✓ Please use designated porta potty for restroom.
- ✓ This is a small, private facility please be respectful of our home and facility.
- ✓ Hours: Sunrise to Sunset. Please contact us in advance if you plan to come out outside of standard business hours.
- ✓ Board payment is due between the 1st day of camp, a late fee will be charged if received after.

THIS AGREEMENT, for good and valuable consideration receipt of which is hereby acknowledged, dated the _____ day of _____, 20____. made by and between Cedar Ridge Equine, hereinafter referred to as "CEDAR RIDGE EQUINE, LLC.," providing services as an independent contractor, located at 555 Rocky Road, Bozeman, MT. 59718 and (Horse Owner's name) _____ residing at (Horse Owner's address) _____, hereinafter referred to as "OWNER." These parties warrant that they have the right to enter into this AGREEMENT.

1. FEES, TERMS AND LOCATION

In consideration of \$ 13 per horse per day paid by OWNER in advance on the **First** day of stay with us. CEDAR RIDGE EQUINE, LLC., agrees to board the herein described horse (s) on a month to month basis commencing _____, 20__.

3. FEED AND FACILITIES

CEDAR RIDGE EQUINE, LLC., agrees to provide the following, in addition to normal and reasonable care and handling to maintain the health and well-being of the horse (s).

4. VACCINATIONS

Upon arrival of horse to Cedar Ridge Equine, LLC. proof of current vaccinations must be provided. (Recommended to be vaccinated for West Nile virus + Eastern Equine Encephalomyelitis, Tetanus). A negative current Coggins test and health certificate is required for all horses arriving from out of state.

5. RISK OF LOSS

During the time that the horse (s) is/are in the custody of Cedar Ridge Equine, LLC., Cedar Ridge Equine, LLC. shall *not* be liable for any sickness, disease, theft, death or injury which may be suffered by the horse. This includes, but is not limited to, any personal injury or disability the horse may receive while at Cedar Ridge Equine, LLC., premises. OWNER fully understands and hereby acknowledges that Cedar Ridge Equine, LLC., does not carry any insurance on any horse (s) not owned by Cedar Ridge Equine, LLC., including, but not limited to, such insurance for boarding or any other purposes, for which the horse(s) is/are covered under any public liability, accidental injury, theft or equine mortality insurance, and that all risks relating to boarding of horse (s), or for any other reason, for which the horse (s) is/are in the possession of Cedar Ridge Equine, LLC., *are to be borne by OWNER.*

6. HOLD HARMLESS

OWNER agrees to hold Cedar Ridge Equine, LLC., harmless from any claim resulting from damage or injury caused by said horse, OWNER or his guests and invitees, to anyone, including but not limited to legal fees and/or expenses incurred by Cedar Ridge Equine, LLC., in defense of such claims.

7. LIABILITY INSURANCE

OWNER warrants that he/she presently carries in full force and effect, and throughout the period of this AGREEMENT shall continue to carry and maintain in full force and effect, liability insurance protecting OWNER and Cedar Ridge Equine, LLC., from any and all claim (s) arising out of or relating to this AGREEMENT.

8. EMERGENCY CARE

Cedar Ridge Equine, LLC., agrees to attempt to contact OWNER, at the following emergency telephone number (_____), should Cedar Ridge Equine, LLC., feel that medical treatment is needed for said horse (s), provided however, that in the event the Cedar Ridge Equine, LLC., is unable to so contact OWNER within a reasonable time, which time shall be judged and determined solely by CEDAR RIDGE EQUINE, LLC., CEDAR RIDGE EQUINE, LLC., is then hereby authorized to secure emergency veterinary care and/or blacksmith care, and by any licensed providers of such care who are selected by CEDAR RIDGE EQUINE, LLC., as CEDAR RIDGE EQUINE, LLC., determines is required for the health and well-being of said horse (s). The cost of such care secured shall be due and payable by OWNER within fifteen days from the date OWNER receives notice thereof, provided however, that CEDAR RIDGE EQUINE, LLC., is authorized to arrange direct billing by said care provider to the OWNER.

9. CEDAR RIDGE EQUINE, LLC., RULES

Owner hereby acknowledges receipt and understanding of the current CEDAR RIDGE EQUINE, LLC., Rules, which are incorporated by reference in full, as if fully set forth herein. OWNER agrees he/she and his/her guests and invitees will be bound and abide by these Rules, and accepts responsibility for the conduct of his guests and invitees according to these Rules. OWNER acknowledges the Rules include but are not limited to:

Boarding Agreement

1. Always clean up after you and your horse: manure, hair, etc., this includes any manure left behind from your horse. This includes Cedar Ridge Equine, LLC., areas, tie up areas, riding arenas, and round pen.
2. Please check the calendar to find out when open riding is available at the arena. Trainers have first priority for use of the arena/s.
3. Everyone must sign a release of liability form before participating in any equine activity.
4. All guests must sign a release of liability form before riding at the Cedar Ridge Equine facility.
5. All dogs must be on a leash when on premises of Cedar Ridge Equine.
6. Please be respectful of our neighbors and our road. Do not speed, stay under posted limits.

CEDAR RIDGE EQUINE, LLC., may revise these Rules from time to time and OWNER agrees any revision shall have the same force and effect as current Rules. Failure, as determined in CEDAR RIDGE EQUINE, LLC.,'s sole discretion, of OWNER or OWNER's guests and invitees to abide by CEDAR RIDGE EQUINE, LLC., Rules may result in CEDAR RIDGE EQUINE, LLC., declaring OWNER in default hereunder and result in termination of this AGREEMENT.

10. DEFAULT

Either party may terminate this AGREEMENT for failure of the other party to meet any material terms of this AGREEMENT, including but not limited to item 9 Cedar Ridge Equine, LLC., Rules. In the case of a default by one party, the other party shall have the right to recover legal fees and expenses, if any, incurred as a result of said default. Any payment due CEDAR RIDGE EQUINE, LLC., under this AGREEMENT shall be due and payable by the tenth day of the month and immediately in the event of termination. Failure to make any payment by said due date shall place OWNER in default hereunder. Acceptance by CEDAR RIDGE EQUINE, LLC., of any late payment shall not constitute a waiver of subsequent due dates or determinations of default.

11. ASSIGNMENT

This AGREEMENT may not be assigned by OWNER without the express written consent of CEDAR RIDGE EQUINE, LLC.,.

12. NOTICE OF TERMINATION

OWNER agrees that thirty (30) days notice shall be given to CEDAR RIDGE EQUINE, LLC., as to the termination of this AGREEMENT.

13. RIGHT OF LIEN

OWNER is put on notice that CEDAR RIDGE EQUINE, LLC., has and may assert and exercise a right of lien, as provided for by the laws of the State of Montana for any amount due for the board and keep of horse (s), and also for any storage or other charges due hereunder, and further agrees CEDAR RIDGE EQUINE, LLC., shall have the right, without process of law, to attach a lien to your horse (s) after two (2) months of non-payment or partial payment and CEDAR RIDGE EQUINE, LLC., can then sell horse (s) to recover its loss.
